Privacy Notice for Stakeholders

1. Privacy Notice

Your privacy is important to us. We want you to be informed and familiar with how we collect, use and disclose data ("processing") directly or indirectly relating to you as an individual ("personal data").

This Privacy Notice (hereafter referred to as "**Privacy Notice**") describes how **Syngenta Magyarország Korlátolt Felelősségű Társaság (1117 Budapest, Alíz utca 2.)** (hereafter referred to **Syngenta Kft.**) (hereinafter referred to as "**we**", "**our**" and "**us**") processes your personal data collected in relation to your professional relationship (business communication, sending invitations to conferences and to other events etc.) with Syngenta Kft.

The Privacy Notice describes the types of personal data we collect either from you or from publicly available sources during our professional relationship with you and how we process your personal data, which parties we share your personal data with (and where they are located), the duration for purpose of retention and your choices regarding our use of your personal data. We also describe how you can contact us about our privacy practices. We thank you for reading this Privacy Notice carefully.

2. Processing your personal data

Your personal data is either collected from the following publicly accessible sources (<https://www.kormany.hu>; <https://www.naik.hu>; <https://www.keh.hu>; <https://www.hucpa.hu>; <https://www.okologia.mta.hu>; <https://www.koti.szie.hu>; <https://issuu.com/agroinformcom>; <https://iccopr.com>; <https://www.supplychaininitiative.eu/registry/nestlé>) or directly from you for the following purposes:

- *business related / professional communication with you (e.g. sending invitations to conferences, sending other business-related information;*
- *building up business related database (containing stakeholders' contact data)*

Your personal data will be processed (e.g. stored, organized and used) by Syngenta Kft. for the above purposes. Your personal data will not be transferred to any third parties.

The legal basis of the data processing for the above purpose is the following: *Syngenta Kft's legitimate interest (GDPR Art 6 1 (f))* as it is Syngenta Kft's legitimate interest to be able to communicate with you and keep professional contact with you (e.g. invite you to conferences and other events). The processing of your data is essential for keeping contact with you, we only use the minimum set of personal data which is necessary for our above described processing purposes and there is no alternative method to achieve our purpose. In this regard, the processing of your data does not negatively impact your rights.

Syngenta Kft. processes the following type of personal data in relation with the above purposes: *name, contact details (e-mail address, phone number), your position (and the organization you represent)*

We intend to keep your personal data accurate and up-to-date. We do not wish to store your data for longer than is necessary for the relevant purpose as described above. *Primarily, we store your data until Syngenta Kft. has a professional relationship with you (e.g. until we would contact you) or alternatively, until you request the erasure of your personal data by Syngenta Kft.*

Statement on cookies:

Cookies: We use "cookies" and other web technologies to collect information and support certain features of our websites. For more information see our Cookies Policy where you can manage your cookie consents [<https://www.syngenta.hu/suti-cookie-szabalyzat>].

The legal basis for processing activities related to essential cookies is our legitimate interest in lawfully operating our website (in accordance with Article 6(1)(f) GDPR). The legal basis for processing activities related to non-essential cookies (preference cookies, statistics cookies, marketing cookies) is your consent (in accordance with Article 6(1)(a) GDPR).

3. Exercising your rights

We strive to maintain a high level of transparency about the data we process. As regards our processing of your personal data described in this Privacy Notice, you have the following rights in relation to your personal data:

- To confirm Syngenta is processing your personal data, to get access to or receive a copy of the personal data we may have about you;
- To require us to rectify or update any inaccurate personal data, or complete any incomplete personal data;
- To require us to delete or erase your personal data;
- To restrict our processing of your personal data;
- To require us to transmit certain of your personal data to you or to transfer or have them transferred to another data controller (portability) in case the legal basis of the processing is your consent or the contract concluded by you; and
- To require that we stop processing your personal data for the above purposes (object).

We will respond to your request as quickly as possible after validating the request.

We will promptly modify your personal data if we agree that it is either inaccurate, out of date, incomplete, irrelevant or misleading, after taking into account the purposes for which it was collected. If we correct it and had previously disclosed it to a third party, we will also notify that third party if required to by law.

If we disagree with your request, we will explain the reason for refusal and the ways you can complain.

4. Questions, concerns and complaints

Furthermore, you are entitled to file an action at the competent court).
